

Terms & Condition:

The Applicant(s) must read and understand the rules of occupation of the resort governing Wellness Vacation, the Rules of termination and agree to be bound by the rules and regulations contained herein. The term of the membership shall continue until the termination date of the scheme or cancellation of it

The Company

The Company is Vedic Resorts and Hotels Pvt. Ltd., who are Developers of Vedic Village Spa Resort.

Membership Fees

The entire fees need to be paid in full to be enrolled for the Membership plan.

Membership fee means that total fee payable to Vedic Resorts and Hotels Pvt. Ltd

as per price structure fixed of the Membership Plan. Can also be paid in

installments. In the installment payment scheme the member agrees to pay his/her

installments on the specified date.

In case of default of installment payment, the membership will be automatically cancelled and the member will not be entitled of any benefits of membership.

Membership Card

Upon the applicant completing all payment due under this agreement the Company shall within 30 days, issue to the applicant on receipt of member's photo, membership card along with the Welcome Kit, specifying the applicant(s) entitlements. The member can only avail the membership benefits on being personally present along with the photo membership card. The rooms and Spa credits are non-transferable to others. Till the time the client is not issued the membership card, a letter will be given mentioning the member's name. The member will have to carry the letter and a generally accepted photo ID card.

The Applicants understands that the number of people who can occupy a room is 2 Adults and 1 Child below 6 years.

Reservation and Benefits

The applicant understands that confirmation for reservation is subject to availability of rooms at the resort and the membership benefits cannot be clubbed with any other offers. Room reservation cancellation is allowed 72-hour prior to arrival date post which the room nights would be deducted from the member's account. The membership card will be issued to the Primary Member, his/her spouse, the primary member's parent's and two children below 18 years. All will be considered as members. No other relations can be included in the membership.

Right of Occupation & Spa

The applicant(s) is/ are entitled to 12 room nights and 24 Spa treatments in 3 years in a standard room with a maximum of 5 room nights in a year at the resort along with 10 Spa treatments in a year. Each Spa treatment is for a duration of 50 minutes... (Need to avail 6 room nights and 12 Spa treatments in 1 year)

Refunds

Once enrolled for the membership there would be no refund of the membership fees.

Exit Clause

It is also understood by both the parties that the company may terminate the membership if the applicant (s) do not adhere to House policies of the resort or indulge in activities which are against the law. There is no refund policy in the Exit

Clouse.

Final Agreement

This Agreement upon execution is legally binding and final and on both the parties. The applicant(s) acknowledges(s), that they have entered into this

Agreement on their free will and desire.

Force Majeure

If performance of any obligation aforementioned is prevented or delayed in the whole or in part by reason of an act of God, or the consequences there of such

an act including but not limited to fire, flood, typhoon, earthquake or by reason of riots, wars hostilities, governmental restrictions including delay in or restriction of issuance of permits or licenses, permits of approvals, strikes, lockout or labor disputes the affected party shall be given additional equal to

such delay caused directly thereby for due performance of their part of the obligation, embargoes. " .."

Taxes & Levies

Modification

No modification of this membership application terms and conditions shall be valid unless made in writing and signed by the applicant / member
